- One of the key features of GatesToken is its limited supply
- There will only ever be 1 billion GatesToken in existence; 400 million will never be released into the market as this give it value over time

- If you're interested in GatesToken, make an investment amount that you can afford without breaking a sweat for a few years to maximize your return


5 IS YOUR MONEY PROTECTED WHEN IT'S IN GATESTOKEN?
